Benefits under the Asylum Seekers' Benefits Act (AsylbLG) here: Checking your eligibility requirements and submitting the required documents

Dear Madam or Sir,

You are currently receiving benefits under the Asylum Seekers' Benefits Act.

Your residence status (leave to remain, permission, etc.) will soon expire, which means the eligibility requirements according to Section 1 AsylbLG must be checked. I would like to request the following documents:

- current residence status (leave to remain, permission, etc.)
- alternatively, residence certificate from the immigration office or appointment confirmation
- bank statements for the last six months for all accounts / savings books of the people in the household (if they have an account)
- if applicable, pay slips (if not already provided)
- attached change notification completed and signed

If the above documents are not received by the date mentioned, no further benefits can be paid. If you need help filling out the change notification, you are welcome to come to the daily asylum clinic.

Please note:

Anyone applying for or receiving social benefits must disclose all facts relevant to the benefit and immediately report any changes in their circumstances (Section 9(3) of the Asylum Seekers' Benefits Act (AsylbLG) in conjunction with Section 60 of Book I of the German Social Code (SGB I)). If you have not responded by the deadline or have not submitted the required documents, you may be refused cash benefits until you have done so (Section 9.3 AsylbLG in conjunction with Sections 60, 66, 67 SGB I). This means that you and the people living with you in the household will not receive any benefits.
